We would like ask those homeowners whose property is adjacent to the Greenbelt to clear the dry grass and weeds at least 20 to 30 feet from their fence. POOL POICY

Since the pool has been open this season there has been an increase in incidents of individuals not adhering to the pool policies. Pool policies were developed by the OHHA board, and are based on safety and common sense. These incidents have included a vomiting incident in the spa, a leaky dirty diaper in the spa, gummy bears coating the spa area floor, and eating in the spa area. When the pool area is cleaned after a weekend, we find empty glass and other alcoholic beverage containers in the trash cans around the pool and the spa.

Drug (heroin) paraphernalia has been found in the men's bathroom. The sheriff was called, but the user could not be identified. A person doing drugs isn't going to be waving it around so the camera can see it. Same with the alcohol, it is hidden in beach bags.

Did you know that the rules you signed when you got your pool card require that guests using the pool must be accompanied by an OHHA resident? Children under the age of 14 are not supposed to be at the pool without a parent or guardian. The pool is not a safe place for unsupervised children. You are the responsible party for your pool key. If you lend your key to others, or let people into the pool area, you are responsible for any damages that may occur. All the pool rules can be found on the OHHA website at www.oakhillshoa.org.

Just inside the front gate there is a display case on the right that has phone numbers for board members. These can be used to report incidents or problems. Neither OHHA Board members nor staff are on call 24 hours a day. If you fear for you safety, call the Sheriff.

I don't know what the solution is to get residents to obey the rules. Increasing OHHA dues, so that we can have a pool monitor to check all your bags before you go into the area, would not be a popular way to address the issue. So please, read your pool policies again, and follow them. It makes life easier for everyone who lives in Oak Hills

MONTEREY COUNTY CODE TITLE 14

Some residents of the OHHA have requested permission to drive over curbs to access their side yards or backyards. Others drive over the curbs and OHHA property without permission. It is important to note that the OHHA does not own the curbs that line our public roads. Monterey County owns all curbs that are part of roads maintained by public funds.

Permission to drive over curbs lining County roads must be obtained from the County Board of Supervisors following their prescribed permitting process. Application for a permit to drive over County curbs must be made in writing to the County Public Works Director and must include clear evidence of permission from any abutting property owner, including the OHHA.

For more information concerning this ownership issue please consult <u>Monterey County Code</u> <u>Title 14</u>, which clearly states that all parts (including curbs) of any public road in Monterey County open to public travel and maintained by public funds is owned by the County.
