Greenbelt Cleanup Days

Recently members of the Oak Hills Homeowners Board and other volunteers got together on consecutive weekends to clear out some brush and dead trees from the greenbelt areas.

On the first weekend, they cleared large areas of undergrowth and overgrown bushes, and brought down six dead trees before they came down and created potential problems later. On the second weekend the group spent seven hours with a wood chipper

to dispense with the cut debris. This was turned into mulch and spread around back into the greenbelt to recycle the waste.

Recent wildfires throughout the state have brought attention to this as a serious problem. Homeowners are urged by the Fire Marshal to clear 20 feet from the back side of their fence as a safety precaution.

There is still more work to be done within the greenbelt areas throughout Oak Hills. By doing the work ourselves, we save the Association a significant amount of money and in turn save each of you money from increased assessments to cover such costs. And high school community service credits can be earned for students who wish to volunteer as well.
