OHHA Recreation Facilities to Get Needed Upgrades: Will Cause Short Term Closures

Swimming and hot tubbing at the association owned recreation facilities will be put on hold a while as the place gets a needed face-lift. The first phase of improvements is due to begin on the re-surfacing of the hot tub March 1 and should be completed by March 23. In the next phase, the pool decking is going to be removed and replaced. This larger scale project is tentatively scheduled to be completed in early April. And the last and final phase of the undertaking will involve new security fencing, improved lighting and signage, and a more comprehensive security system. The entire project will be funded by reserve funds already put aside for such ventures.

Stay posted, much of the work is subject to securing permits, materials, prevailing weather and contractors' schedules. Watch the bulletin board at the Pool House for the posting of day-to-day news. And remember, good things come to those who are patient.
